Report of Proceedings

1. OPENING

Grand Lodge was opened in Ample Form and the Presiding Officer, Most Worshipful Brother Raymond John Smith, P.Pro G.M., was saluted under the direction of the Grand Director of Ceremonies.

18. ADDRESS BY THE MOST WORSHIPFUL PRO GRAND MASTER

The Most Worshipful Pro Grand Master addressed Grand Lodge as follows:
